Release: Shipper hereby voluntarily releases and forever discharges Wings of An Angel Transport and it's agents, employees from any and all liabilities, claims, demands, actions or rights of actions, which are related to, rise out of, or are in anyway connected with the transport, care or feeding, any and all injury, illness or disease, and damage of the aforementioned horse(s) including, but not limited to the negligent acts or omissions of Wings of An Angel Transport and it's agents, employees. If the Shipper elects not to secure other insurance, then he/she agrees that he/she assumes all expenses or liabilities associated with the transport or care of the aforementioned horse(s). Shipper hereby holds harmless Dan & Kim LaPierre and Wings of An Angel Transport for any liability that would incur for property damage or bodily injury to any horse(s) and / or owners / passengers loading, transporting, unloading, or handling the aforementioned horse(s).

Cancellations: Wings of An Angel Transport agrees to provide a full refund of Shipper's deposit if transportation must be cancelled due to hazardous weather, mechanical difficulties or extenuating circumstances. If Shipper notifies Wings of An Angel Transport at least 10 days prior to Wings of An Angel Transports departure for scheduled trip, all monies will be refunded.

If cancellation occurs 72 hours (3days) or less prior to Wings of An Angel Transports departure for scheduled trip, all monies will be refunded, except for a \$50 cancellation fee.

Payment: A deposit of at least 50% of the shipping fee is due in advance and may be mailed with the contract or otherwise forwarded to Wings of An Angel Transport. Prior to being scheduled Shipper must provide Wings of An Angel Transport clear, detailed directions to the point of pickup and delivery. The balance of the shipping fee must be paid either in advance, at pickup, or at the delivery point prior to unloading of any horse(s).

Non-Payment: If the balance is not paid at the latest upon delivery of the horse(s), Wings of An Angel Transport shall be entitled to recover from Shipper all costs and damages incurred by the Wings of An Angel Transport, including boarding costs and reasonable attorney's fees, and shall have a lien against the transported horse(s) for the value of services rendered. Wings of An Angel Transport shall be entitled to enforce said lien in accordance with appropriate state laws.
